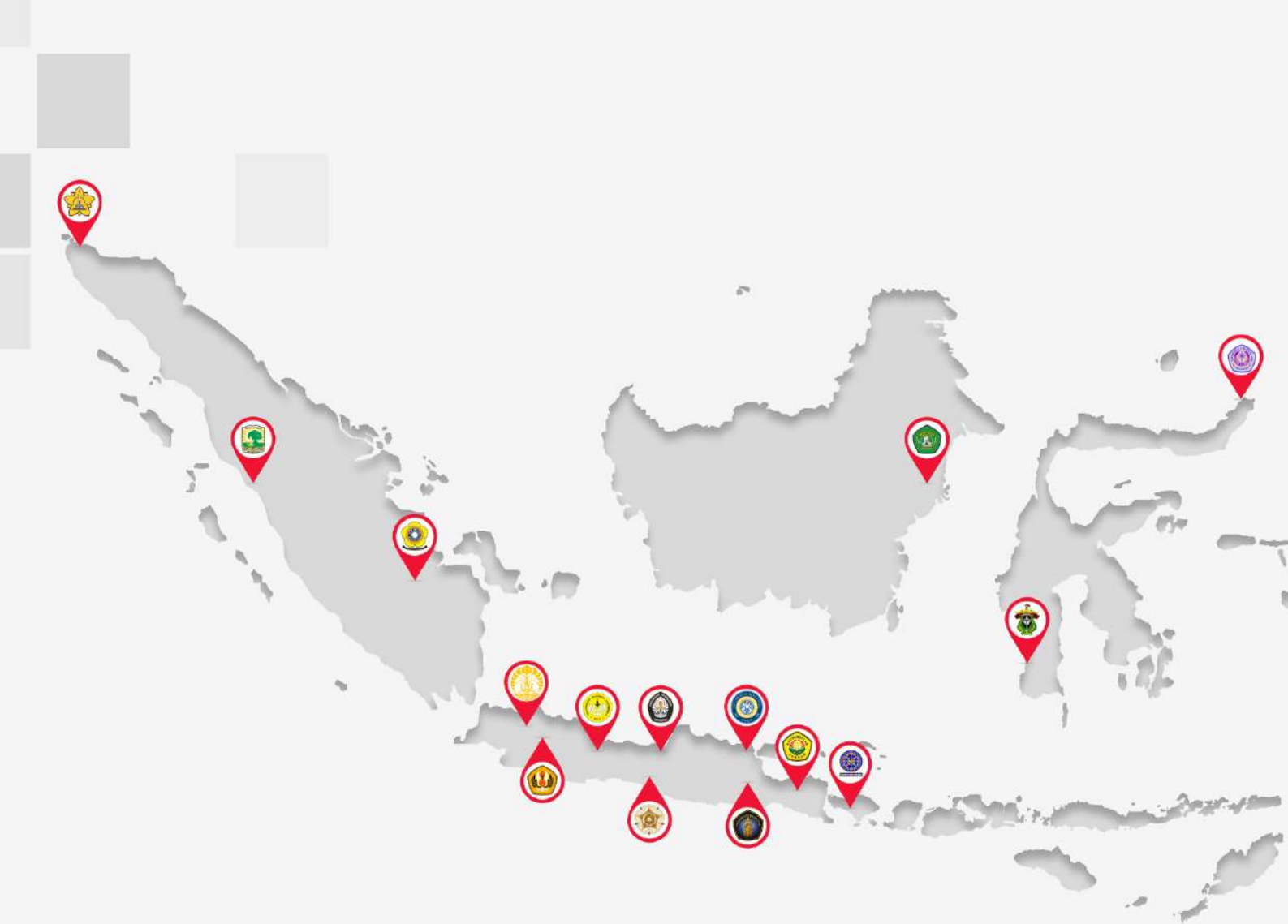

ALSA INDONESIA'S MILESTONE



1989

Establishment of the ASEAN Law Students' Association in Jakarta.

1996

Inspired by the European Law Students' Association, Japanese law students decided to establish the Asian Law Students' Association in East Asian countries.

2001

The Seoul Declaration was issued, where ALSA Japan, ALSA Korea, ALSA Taiwan, and representatives from Peking University agreed to further discuss creating a regional law student network.



2002

The five founding ASEAN members (Indonesia, Malaysia, the Philippines, Singapore, and Thailand) proposed expanding ALSA's membership to advance its objectives.

At the Korean Conference and Asian Forum in Japan, merging with the ASEAN Law Students' Association was agreed upon by members from East Asian countries and ASEAN members.

The Tokyo Agreement was signed on 7 September 2002, marking the decision to unify into a single association.

2003

On 23 October 2003, a resolution was passed unanimously in Bangkok by all member associations—ASEAN Law Students' Association, ILSA PKU, LA, HKUSU, ALSA Japan, ALSA Korea, and ALSA Taiwan—officially merging into one unified ALSA.

2003- Present

Continuous growth and establishment of 15 local chapters across Indonesia, with significant contributions to ALSA's and Asian Law student development.

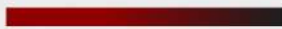
